### LIMITED WARRANTY

# **Vertical Power Product Line**

(the "Manufacturer") warrants its Vertical Power product line hardware products to be free from defects in materials and workmanship under normal use and environmental conditions for the periods listed below. The warranty period will commence on the date of shipment to the retail customer from the Manufacturer or its authorized distributor (Distributor), as evidenced by providing a copy of Distributor's retail invoice which shows model numbers, serial numbers and actual ship dates to the end-user. If the end-user is unable to provide a copy of the retail invoice, the start date of the warranty will commence on the date shipped from the Manufacturer's facility. However, in no case will the start date of the warranty extend beyond twelve months of shipping date from the Manufacturer's facility. This limited warranty does not cover products damaged by accident, disaster, misuse, abuse, or unauthorized modifications. Opening the case of a sealed product voids this warranty.

Vertical Power branded hardware assemblies: 2 year limited warranty.

Cables and other accessories: 90 day limited warranty.

Manufacturer warrants its software products to perform substantially in accordance with their accompanying written materials for a period of ninety (90) days from delivery.

The warranty for third party products resold by Manufacturer is limited to the warranty provided by the third party.

### **CUSTOMER REMEDIES**

Should the product fail to be in good working order during the warranty period, the Manufacturer's sole obligation shall be at its option, to repair, correct or replace the product, or, at Manufacturer's sole discretion, to refund amounts paid for such product upon its return to a location designated by Manufacturer in the United States. Manufacturer shall pay for the return of the product to the Customer to a location within the United States. Customer shall be responsible for paying all shipping charges, duties, taxes, and any other charges for products returned to any other locations.
